Purposes of the processing for which the personal data are intended, as well as the legal basis for the processing	Ferrocam Srl processes the personal data you provide for the following purposes: <ul style="list-style-type: none"> ▪ Execution of contracts and orders provisions ▪ Administrative and tax management of contracts and orders ▪ Responding to requests for information ▪ Commercial, promotional, or marketing purposes. <p>The legal basis for data processing is the fulfillment of contractual and pre-contractual purposes for which EU Reg. 2016/679 does not provide explicit consent.</p>
Processing methods	Ferrocam Srl processes users' personal data by adopting the appropriate security measures to prevent unauthorized access, disclosure, modification, or destruction of personal data . The processing is carried out using informatics and/or telematic tools .
Categories of data processed	Ferrocam Srl manages contractual and pre-contractual relationships by processing common data, which could be provided to the supervisory authorities upon explicit request. In any case, Ferrocam Srl ensures that the minimum data will be collected to guarantee the provisions of the contract and the orders.

Retention period of personal data	Personal data are processed for the time necessary to perform the service requested by the user or required for the purposes described in this document. Longer times are provided for the fulfillment, by the controller, of obligations imposed by the law in force.
Where your personal data are stored	Personal data are processed at the operational offices of Ferrocam Srl in Bienno (BS) and Berzo Inferiore (BS) and any other place where the parties involved in the processing are located.
Intention of the data Controller to transfer personal data to a third country or to an international organization	Ferrocam Srl does not transfer personal data to third countries or international organizations.

In the event of rectification, cancellation, or limitation of the processing of the data provided by you, if you request it, FERROCAM Srl, in its capacity as data controller, will inform the aforementioned third-party companies and the recipients of the processing.</p>

<p>Right to lodge a complaint with a supervisory authority</p>	<p>As a data subject, you have the right to lodge a complaint with the competent supervisory authority.</p>
<p>Existence of legal or contractual obligations or requirements necessary for the conclusion of a contract</p>	<p>Failure to authorize the processing will make it impossible to proceed with the execution of the provisions of the contracts and orders.</p>
<p>Defense in court</p>	<p>The user's personal data may be used by Ferrocamm Srl in court or the preparatory phases for its possible establishment for the defense of abuses in the use of the same.</p>
